



**A Resolution of the Board of Commissioners of King County Fire Protection District No. 13
Changing the Name of the Fire District**

WHEREAS, King County Fire Protection District No. 13, Vashon, King County, Washington has at all times in its existence been known by such name; and

WHEREAS, the name King County Fire Protection District No. 13 does not offer any indication of the area it serves; and

WHEREAS, the Board of Commissioners has determined it is in the Fire District's best interest to change its name to Vashon Island Fire and Rescue; and


WHEREAS, RCW 52.30.060 provides a procedure for a fire protection district to change its name;

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners of King County Fire Protection District No. 13, Vashon, King County, Washington, that the Fire District shall henceforth bear the name of **Vashon Island Fire and Rescue**. This resolution shall become effective upon approval by the King County Council, pursuant to RCW 52.30.060.




