1 AN ORDINANCE approving the Bryn Mawr-Lakeridge
2 Water and Sewer District Comprehensive 1999 Sanitary
3 Sewerage Plan.

PREAMBLE:

5 K.C.C. chapter 13.24 requires approval of comprehensive plans for sewer
6 utilities as a prerequisite for granting right-of-way franchises and approval of
7 right-of-way construction permits.

8 The Bryn Mawr-Lakeridge Water and Sewer District Comprehensive 1999
9 Sanitary Sewerage Plan ("plan") discusses public sewer service to existing and
10 future populations in the unincorporated urban area of West Hill (between
11 Seattle and Renton). The area is predominantly comprised of single-family
12 residences. Very little future development is expected.

13 The King County utilities technical review committee ("UTRC") reviewed
14 and conditionally approved the plan on April 19, 2000. The conditions of
15 UTRC approval, technical changes to the plan, have been met and are
16 reflected in the final version attached to this ordinance.

Of primary concern during the UTRC review was the very high levels of infiltration and inflow ("I/I") in the district. The district has committed to participate in the county's regional I/I program.

17 The district prepared a determination of nonsignificance for the plan on June
18 30, 2000, in accordance with the state Environmental Policy Act.

19 The district approved the plan on July 19, 2000.

20 The UTRC recommends that the council approve the plan.

21 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

22 SECTION 1. The Bryn Mawr-Lakeridge Water and Sewer District

23 Comprehensive 1999 Sanitary Sewerage Plan, Attachment A to this ordinance, is hereby

24 approved without conditions.


