1 AN ORDINANCE authorizing the executive to enter into
2 an amendment to the Conservation Futures Interlocal
3 Cooperation Agreement with the city of Lake Forest Park
4 for the Grace Cole Memorial park acquisition project,
5 authorized under Ordinance 14409.

8 **STATEMENT OF FACTS:**

9 1. Conservation futures tax levy funds are collected through King County
10 as a dedicated portion of the property tax and are, by statute, available
11 only for the acquisition of open space and resource lands.

12 2. Ordinance 13717 established a process for the distribution of
13 conservation futures tax levy funds.

14 3. On July 19, 2002, by Ordinance 14409, the King County council
15 allocated \$50,000 in conservation futures funds to the city of Lake Forest
16 Park (city) Grace Cole Memorial park acquisition project.

17 4. The county desires to disburse conservation futures funds to the city
18 and must do so by amending the existing conservation futures interlocal
19 cooperation agreement with the city.

20 5. King County is authorized to enter into interlocal agreements with the
21 cities pursuant to chapter 39.34 RCW, the Interlocal Cooperation Act.

22 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

23 SECTION 1. The King County executive is hereby authorized to enter into an
24 amendment to the Conservation Futures Interlocal Cooperation Agreement with the City
25 of Lake Forest Park for Open Space Acquisition Projects, in substantially the form of

26 Attachment A to this ordinance, for the for the Grace Cole Memorial park acquisition
27 project, authorized under Ordinance 14409.



**AMENDMENT TO THE CONSERVATION FUTURES
INTERLOCAL COOPERATION AGREEMENT
BETWEEN KING COUNTY AND THE CITY OF LAKE FOREST PARK
FOR OPEN SPACE ACQUISITION PROJECTS
February 20, 2003**

Preamble

The King County Council, through Ordinance 9128, has established a Conservation Futures Levy Fund and appropriated proceeds to King County, the City of Lake Forest Park and certain suburban cities through the procedures set forth in Ordinance 8867, as amended by Ordinance 13717. This amendment is entered into to provide for the allocation of additional funds made available for open space acquisition.

THIS AMENDMENT is entered into between the CITY OF LAKE FOREST PARK and KING COUNTY, and amends and attaches to and is part thereof of the existing Interlocal Cooperation Agreement entered into between the parties on the 5th day of June, 1990, as previously amended.

The parties agree to the following amendments:

Amendment 1: Article 1. Recitals

A paragraph is hereby added to the Recitals Section to provide for a Conservation Futures Levy Fund allocation for the Grace Cole Memorial Park Addition, and hereafter reads:

- On July 19, 2002 the King County Council passed Ordinance 14409, which appropriated a total of Fifty Thousand Dollars (\$50,000) in Conservation Futures Levy proceeds to the City of Lake Forest Park for the Grace Cole Memorial Park Addition acquisition Project. On _____ The King County Council passed Ordinance _____, authorizing the King County Executive to enter into interlocal agreements with the City of Lake Forest Park for the disbursement of Conservation Futures Funds in Ordinance _____.

Amendment 2: Article V. Conditions of Agreement

Section 5.1 is appended to include Attachment C, which lists a 2002 Conservation Futures Levy Allocation for the Grace Cole Memorial Park Addition Acquisition project.

Amendment 3: Article VII. Responsibilities of County

The first two sentences of this article are appended to include Attachment C, which lists a 2002 Conservation Futures Levy proceeds allocation for the Grace Cole Memorial Park Addition Acquisition Project:

Subject to the terms of this agreement, the County will provide Conservation Futures Levy Funds in the amounts shown in Attachments A through C to be used for the Projects listed in Attachments A through C. The City may request additional funds; however, the County has no obligation to provide funds to the City for the Projects in excess of the total amounts shown in Attachments A through C. The County assumes no obligation for the future support of the Projects described herein except as expressly set forth in this agreement.

In all other respects, the terms, conditions, duties and obligations of both parties shall remain the same as agreed to in the Interlocal Cooperation Agreement as previously amended.

This document shall be attached to the existing Interlocal Cooperation Agreement.
