1	AN ORDINANCE approving the Union Hill Water
2	Association Comprehensive Water System Plan.
3	
4	
5	PREAMBLE:
6	K.C.C. chapter 13.24 requires approval of comprehensive plans for water
7	utilities as a prerequisite for granting right-of-way franchises and approval
8	of right-of-way construction permits.
9	The Union Hill Water Association currently provides water service to six
10	thousand five hundred residents and several schools and businesses. The
11	association is located east of the city of Redmond in rural King County.
12	The association obtains its water from a well and an intertie with the city
13	of Redmond. Additional wells are available for emergency use. The
14	average annual water demand is currently eight hundred ninety thousand
15	gallons per day. The demand is projected to increase to about nine
16	hundred thirty-five thousand gallons per day in 2024, assuming a modest
17	water conservation reduction of one-half percent per year.

18	The association is currently in moratorium because its instantaneous water
19	rights are not sufficient to meet its peak demands, although its annual
20	water rights are sufficient for the next twenty years. The association
21	intends to address this peak day supply constraint through construction of
22	additional storage.
23	The association is proposing a twenty-year capital improvement program
24	valued at nearly \$19,000,000. The capital improvements proposed include
25	modifications to the storage, treatment, and distribution systems.
26	The King County utilities technical review committee ("UTRC") reviewed
27	and conditionally approved the plan on March 10, 2004. The conditions
28	of approval have been met in the plan copies attached to this ordinance.
29	The UTRC recommends that the council approve the plan.
30	A determination of nonsignificance for the plan was issued by King
31	County on behalf of the association on September 21, 2004, in accordance
32	with the state Environmental Policy Act.
33	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

34 <u>SECTION 1.</u> The Union Hill Water Association Comprehensive Water System

Plan, Attachment A to this ordinance, is hereby approved without conditions.
