9 SECTION 1. Ordinance 15083, Section 114, as amended, is hereby amended by  
 10 adding thereto and inserting therein the following:

11 From capital improvement project funds there is hereby appropriated and  
 12 authorized to be disbursed the following amounts for the specific projects identified in  
 13 Attachment A to this ordinance.

20 Lakewood Park Community Center project 316560 until the executive transmits and the  
21 council approves by ordinance an agreement between the county and the Technology  
22 Access Foundation relating to the construction, ownership, use and operation of the  
23 facility.




