1 AN ORDINANCE establishing the 2006 work program for  
2 the regional policy committee of the King County council.

5 **PREAMBLE:**

6 Section 270 of the King County Charter creates the regional policy  
7 committee to develop, review and recommend to the council those  
8 regional policies and plans for subject matters established in a work  
9 program approved by ordinance. This ordinance establishes the regional  
10 policy committee's 2006 work program and its subject matter for the  
11 regional policy committee.

12 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

13 SECTION 1. Attachment A to this ordinance is hereby adopted as the 2006 work  
14 program and subject matter of the regional policy committee. All countywide policies or  
15 plans related to all subjects in Attachment A to this ordinance must be referred to the  
16 committee by the council. Policies or plans related to these subjects that are not  
17 countywide are not required to be referred to the committee.

18            SECTION 2. In addition to the subjects listed in section 1 of this ordinance, the  
19 committee may propose to amend its work program, subject to adoption by the council by  
20 ordinance, to include countywide policies or plans related to other subject matter that the  
21 committee believes would benefit from interjurisdictional review and recommendations.




