1 AN ORDINANCE relating to the annexation of
2 approximately 19.84 acres to Soos Creek Water and Sewer
3 District, known as Annexation P-367S-R, for the purpose
4 of providing sewer service for future development.

7 **STATEMENT OF FACTS:**

8 1. A notice of intention proposing the annexation of approximately 19.84
9 acres of land into the Soos Creek Water and Sewer District, known as
10 Annexation P-367S-R, for the purpose of providing sewer service for
11 future development was filed with the county council on December 29,
12 2005.

13 2. Soos Creek Water and Sewer District has found the petition for transfer
14 to be sufficient and has concurred with the proposed transfer in Resolution
15 No. 2759-S, passed on November 16, 2005.

16 3. Soos Creek Water and Sewer District made a Determination of
17 Nonsignificance on the proposed annexation in Resolution No. 2758-S,

18 passed on November 16, 2005.

19 4. The utilities technical review committee recommended county council
20 approval of the proposed annexation.

21 5. The county council held the legally required public hearing and has
22 considered the criteria in RCW 57.02.040.

23 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

24 SECTION 1. The annexation of approximately 19.84 acres to Soos Creek Water
25 and Sewer District for the purpose of providing sewer service for future development
26 described in Attachment A of this ordinance is approved. Approval of this proposed
27 annexation is consistent with RCW 57.02.040.

28 SECTION 2. Soos Creek Water and Sewer District is the appropriate entity to
29 serve the area proposed to be annexed.


30 SECTION 3. Completion of this annexation does not constitute county approval

County Council on 4/17/2006, by the following vote:


