8 **STATEMENT OF FACTS:**

- 9 1. Fred V. Habenicht served the Maple Valley community for many
10 years, thereby earning the respect and admiration of residents and county
11 government officials.
- 12 2. Fred V. Habenicht, as a member of the Rotary Club of Maple Valley,
13 was influential more than twenty years ago in beginning efforts, which
14 continue to this day, by the community and the Rotary Club of Maple
15 Valley to clean up and maintain the Maple Valley Trailhead.
- 16 3. Fred V. Habenicht was instrumental in working with the parks
17 department to acquiring one hundred twenty thousand dollars in funding

18 for improvements and maintenance, thus providing a safe area for families
19 of the Maple Valley community to have access to the Cedar river.

20 4. Fred V. Habenicht was admired for his commitment to the needs of his
21 community and that sense of commitment has been institutionalized
22 through the efforts of the Rotary Club of Maple Valley to ensure that his
23 vision for safe and clean access to the Cedar river continue.

24 6. Fred V. Habenicht passed away on June 19, 2006.


25 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:




