1 AN ORDINANCE relating to taxicab and for-hire vehicles,  
2 increasing fees; amending Ordinance 13334, Section 2, as  
3 amended, and K.C.C. 6.64.025.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. Section 2 of this ordinance proposes changes to existing taxicab and  
7 for-hire vehicle fees within the licensing section of the records, elections and licensing  
8 services division.

9 SECTION 2. Ordinance 13334, Section 2, as amended, and K.C.C. 6.64.025 are  
10 each hereby amended to read as follows:

11 **License fees and penalties.**


