1 AN ORDINANCE relating to solid waste management;  
2 making technical corrections; and amending Ordinance  
3 8108, Section 4, as amended, and K.C.C. 10.10.030.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY

6 SECTION 1. Ordinance 8108, Section 4, as amended, and K.C.C. 10.10.030 are  
7 each hereby amended as follows:

8 Types of waste accepted at King County solid waste facilities shall be limited to the  
9 following:

10 A. The Cedar Hills regional landfill shall accept municipal solid waste from  
11 transfer facilities and other sources approved by the division director;

12 B. Transfer facilities shall accept municipal solid waste from commercial and self-  
13 haulers;

14 C. Drop box facilities shall accept municipal solid waste in loads not to exceed  
15 either three cubic yards or one ton (~~(, or both)~~) from commercial and self-haulers;

16 D. Collection areas for yard waste, other organics, or both, located at some county  
17 transfer facilities shall accept source-separated yard waste from commercial and self-

18 haulers. Loads at drop box facilities shall not exceed either three cubic yards ((~~5~~)) or one  
19 ton ((~~5~~ or both));

20 E. White goods collection areas located at some county transfer facilities shall  
21 accept source-separated white goods from residential self-haulers;

22 F. Clean wood collection areas located at county transfer facilities shall accept  
23 source-separated clean wood from commercial and self-haulers;

24 G. Other wastes, such as industrial waste, semisolid ((~~5~~)) or liquid waste and  
25 asbestos-containing waste material, may be accepted at facilities as designated and  
26 approved by the division director; ((and))

27 H. Acceptance of any suspect waste may be denied pending the division director's

28 approval ((-)); and

29 I. Salvaging and scavenging are prohibited at all King County solid waste facilities.






