1 AN ORDINANCE authorizing the interjurisdictional  
2 technical staff group as a standing committee to assist the  
3 ongoing work of the metropolitan solid waste management  
4 advisory committee; and amending Ordinance 14971,  
5 Section 2, as amended, and K.C.C. 10.25.110.

7 PREAMBLE:

8 The metropolitan solid waste management advisory committee  
9 recommends that the interjurisdictional technical staff group continue as a  
10 standing committee to assist the ongoing work of the metropolitan solid  
11 waste management advisory committee.

12 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

13 SECTION 1. Ordinance 14971, Section 2, as amended, and K.C.C. 10.25.110 are  
14 each hereby amended to read as follows:

15 A. A metropolitan solid waste management advisory committee is established.  
16 Each component city with a signed interlocal agreement participating in the county solid  
17 waste management system shall identify representatives and alternates to the solid waste

18 division for appointment to the advisory committee. The committee shall conduct its first  
19 meeting on or after January 2, 2005. The solid waste division shall notify each  
20 component city with a signed interlocal agreement participating in the county solid waste  
21 management system of committee meeting times and locations. At the first  
22 meeting, the committee shall elect a chair. The members of the committee shall serve  
23 at the pleasure of the appointing bodies and shall receive no compensation from King  
24 County other than reimbursement for reasonable expenses actually incurred in the  
25 performance of their duties.

26 B. The metropolitan solid waste management advisory committee shall  
27 advise the executive, the solid waste interlocal forum established in the solid waste  
28 service contracts between the county and cities, and the King County council in all matters  
29 relating to solid waste management and participate in the development of the solid waste  
30 management system and waste export system plan.

31 C. The metropolitan solid waste management advisory committee shall  
32 review and make recommendations on the waste ~~((export))~~ system plan before transmittal  
33 of the plan from the King County executive to the King County council.

34 D.1. ~~((Until the metropolitan solid waste management advisory committee first  
35 convenes, an))~~ The interjurisdictional technical staff group ~~((presently assembled))~~ shall  
36 serve ~~((in lieu of))~~ as a standing committee to assist and support the metropolitan solid  
37 waste management advisory committee in its ongoing work. ~~((The interjurisdictional  
38 technical staff group shall advise the metropolitan solid waste management advisory  
39 committee through April 30, 2007, to assist the committee during its preliminary work.))~~  
40 The interjurisdictional technical staff group shall review draft work products from the

41 solid waste division and make recommendations to the metropolitan solid waste  
42 management advisory committee, as well as other duties that may be requested by the  
43 metropolitan solid waste management advisory committee from time to time. Each  
44 city with a solid waste interlocal agreement with King County, the county executive  
45 and the county council may assign staff to participate in the interjurisdictional  
46 technical staff group. ((The group shall provide a report of its findings and  
47 recommendations by December 31, 2004, to all cities participating in the county solid  
48 waste management system, the King County executive, King County council, the solid  
49 waste advisory committee and the solid waste interlocal forum, or its successor, on the  
50 structure, function and responsibilities of the metropolitan solid waste management  
51 advisory committee. The staff group shall provide a report of its findings and  
52 recommendations by September 28, 2006 March 1, 2007, to all cities participating in the  
53 county solid waste management system, the metropolitan solid waste management  
54 advisory committee, the King County executive, King County council, the solid waste  
55 advisory committee and the solid waste interlocal forum, or its successor.))

56 2. The interjurisdictional technical staff group report shall address at least the  
57 following issues:

58 a. potential modification or replacement of the solid waste interlocal forum, to  
59 identify membership, decision-making responsibilities and scope of duties;

60 b. identification of dispute resolution options;

61 c. development of a framework for financial policies and host city mitigation,  
62 including compensation agreements;

63 d. evaluation of the impact of the proposed waste ((export)) system plan on each

64 of the provisions of the solid waste interlocal agreement between King County and cities;  
65 and

66 e. identification of potential amendments to the solid waste interlocal  
67 agreement.

68 3. The solid waste interlocal forum, or its successor, shall make a  
69 recommendation to the King County executive and the King County council on or before  
70 ~~((September 28, 2006))~~ June 1, 2007, and biennially thereafter on the efficacy of the  
71 continuing role of the interjurisdictional technical staff group ~~((beyond April 30,~~  
72 ~~2007))~~.

73 E. The solid waste division shall provide staff support to the metropolitan solid  
74 waste management advisory committee and the interjurisdictional technical staff group.  
75 The King County council shall provide staff support in the development of solid waste  
76 planning legislation.

78 F. The council supports coordination with the city of Seattle where beneficial on  
79 the siting and operation of intermodal and other waste disposal facilities.




Ordinance 16320 was introduced on 4/30/2007 and passed as amended by the Metropolitan King County Council on 12/8/2008, by the following vote:
