1 AN ORDINANCE relating to appointment and  
2 membership terms on the King County International  
3 Airport roundtable; and amending Ordinance 12785,  
4 Section 3, and K.C.C. 15.94.030.

6 STATEMENT OF FACTS:

7 1. The terms of a majority of the members of the roundtable advisory  
8 committee have expired and those members have continued to serve as  
9 holdover members pending new appointments. These members would not  
10 be eligible for reappointment and confirmation under the current  
11 provisions of K.C.C. 15.94.030.

12 2. It is in the interest of the county, the airport and the roundtable that  
13 these members be allowed to serve one more full or partial term so that  
14 there will be continuity on the committee until new members are  
15 appointed and confirmed.

16 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

17            SECTION 1. Ordinance 12785, Section 3, and K.C.C. 15.94.030 are each hereby  
18 amended to read as follows:

19            A. Regular members, as defined in K.C.C. 15.94.010 (~~(of this chapter)~~), shall be  
20 appointed by the county executive subject to confirmation by the county council. The  
21 executive may appoint (~~(non-voting ex-officio)~~) nonvoting ex officio members who shall  
22 serve at the executive's discretion.

23            B. Except as otherwise provided in subsection C. of this section, (~~(M)~~)members  
24 may be reappointed by the executive to serve up to two full consecutive terms, subject to  
25 confirmation by the (~~(county)~~) council.

26            C. Representatives of Boeing and labor are exempt from term limits.

27            D. Members shall serve a term of three years or until their successor is appointed  
28 and confirmed as provided in this chapter. The terms of office shall be staggered  
29 consistent with (~~(the provisions of)~~) K.C.C. chapter 2.28.

30            (~~(D-)~~) E. A vacancy shall be filled for the remainder of the term of the vacant  
31 position in the manner described in the initial appointment.

32            (~~(E-)~~) F. A majority of the committee shall elect one of its members as chair. The  
33 term of the chair shall be for one year and the chair shall not serve more than two  
34 consecutive terms as chair.

35            SECTION 2. Roundtable members who are serving expired terms as of the  
36

37 effective date of this ordinance may be appointed to serve one additional full or partial  
38 term.




