1 AN ORDINANCE that adopts the 2017 Annual Budget  
2 making appropriations for the capital improvements for the  
3 Harborview Medical Center for the fiscal year beginning  
4 January 1, 2017, and ending December 31, 2017.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. The 2017 Annual Budget making appropriations for the capital  
7 improvements for the Harborview Medical Center is proposed and, subject to the  
8 provisions hereinafter set forth and the several amounts hereinafter specified or so much  
9 thereof as shall be sufficient to accomplish the purposes designated, appropriations are  
10 hereby authorized to be distributed for salaries, wages and other expenses of the  
11 Harborview Medical Center building repair and replacement fund, for capital  
12 improvements and for other specified purposes for 2017.

13 SECTION 2. CAPITAL IMPROVEMENT PROGRAM - The capital budget and  
14 program for 2017-2022 is incorporated as Attachment A to this ordinance. The executive  
15 is hereby authorized to execute any utility easements, bill of sale or related documents  
16 necessary for the provision of utility services to the capital projects described in  
17 Attachment A to this ordinance, but only if the documents are reviewed and approved by  
18 the custodial agency, the real estate services division and the prosecuting attorney's  
19 office. Consistent with the requirements of the Growth Management Act, Attachment A

20 to this ordinance was reviewed and evaluated according to the King County  
21 Comprehensive Plan. Any project slated for bond funding will be reimbursed by bond  
22 proceeds if the project incurs expenditures before the bonds are sold, and an intent to  
23 reimburse motion has been approved by the executive finance committee.

24 From the Harborview Medical Center capital improvement project funds there are  
25 hereby appropriated and authorized to be disbursed the following amounts for the specific  
26 projects identified in Attachment A to this ordinance:
