1 AN ORDINANCE establishing five new capital funds for
2 information technology projects for departments that do not
3 have capital programs; and adding new sections to K.C.C.
4 chapter 4A.200.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 NEW SECTION. SECTION 1. There is hereby added to K.C.C. chapter 4A.200
7 a new section to read as follows:

8 A. There is hereby created the department of community and human services
9 technology capital fund.

10 B. The fund shall be a second tier fund. It is a capital projects fund.

11 C. The director of the department of community and human services shall be the
12 manager of the fund.

13 D. The fund shall account for the proceeds of receipts from transfers from
14 operating funds, bond proceeds, grants, and other revenues identified in the budget
15 process to support approved technology projects. Receipts will be transferred into the
16 capital fund on a reimbursable or scheduled basis.

17 E. The fund shall be used to support technology capital projects which support
18 the operations of the department of community and human services.

19 F. Any subfund of the fund created to hold and manage bond proceeds shall be

20 treated as a first tier fund.

21 NEW SECTION. SECTION 2. There is hereby added to K.C.C. chapter 4A.200
22 a new section to read as follows:

23 A. There is hereby created the department of executive services technology
24 capital fund.

25 B. The fund shall be a second tier fund. It is a capital projects fund.

26 C. The director of the department of executive services shall be the manager of
27 the fund.

28 D. The fund shall account for the proceeds of receipts from transfers from
29 operating funds, bond proceeds, grants, and other revenues identified in the budget
30 process to support approved technology projects. Receipts will be transferred into the
31 capital fund on a reimbursable or scheduled basis.

32 E. The fund shall be used to support technology capital projects which support
33 the operations of the department of executive services.

34 F. Any subfund of the fund created to hold and manage bond proceeds shall be
35 treated as a first tier fund.

36 NEW SECTION. SECTION 3. There is hereby added to K.C.C. chapter 4A.200
37 a new section to read as follows:

38 A. There is hereby created the department of permitting and environmental
39 review technology capital fund.

40 B. The fund shall be a second tier fund. It is a capital projects fund.

41 C. The director of the department of permitting and environmental review shall
42 be the manager of the fund.

43 D. The fund shall account for the proceeds of receipts from transfers from
44 operating funds, bond proceeds, grants, and other revenues identified in the budget
45 process to support approved technology projects. Receipts will be transferred into the
46 capital fund on a reimbursable or scheduled basis.

47 E. The fund shall be used to support technology capital projects which support
48 the operations of the department of permitting and environmental review.

49 F. Any subfund of the fund created to hold and manage bond proceeds shall be
50 treated as a first tier fund.

51 NEW SECTION. SECTION 4. There is hereby added to K.C.C. chapter 4A.200
52 a new section to read as follows:

53 A. There is hereby created the department of public health technology capital
54 fund.

55 B. The fund shall be a second tier fund. It is a capital projects fund.

56 C. The director of the department of public health shall be the manager of the
57 fund.

58 D. The fund shall account for the proceeds of receipts from transfers from
59 operating funds, bond proceeds, grants, and other revenues identified in the budget
60 process to support approved technology projects. Receipts will be transferred into the
61 capital fund on a reimbursable or scheduled basis.

62 E. The fund shall be used to support technology capital projects which support
63 the operations of the department of public health.

64 F. Any subfund of the fund created to hold and manage bond proceeds shall be
65 treated as a first tier fund.

66 NEW SECTION. SECTION 5. There is hereby added to K.C.C. chapter 4A.200

67 a new section to read as follows:

68 A. There is hereby created the general fund technology capital fund.

69 B. The fund shall be a second tier fund. It is a capital projects fund.

70 C. The director of the office of performance, strategy and budget shall be the

71 manager of the fund.

72 D. The fund shall account for the proceeds of receipts from transfers from

73 operating funds, bond proceeds, grants, and other revenues identified in the budget

74 process to support approved technology projects. Receipts will be transferred into the

75 capital fund on a reimbursable or scheduled basis.

76 E. The fund shall be used to support technology capital projects which support

77 the operations of the general fund.

78 F. Any subfund of the fund created to hold and manage bond proceeds shall be
79 treated as a first tier fund.
