1 AN ORDINANCE approving the grant funding allocation
2 for the projects funded through the WaterWorks grant
3 program, Round 5, in accordance with the 2021-2022
4 Biennial Budget Ordinance, Ordinance 19210, Section 112,
5 and Ordinance 18261.

6 STATEMENT OF FACTS:

- 7 1. Ordinance 18031, Section 1, as amended by Ordinance 18261, Section
8 1, established the grant award criteria and process for the WaterWorks
9 grant program in accordance with the 2015/2016 Biennial Budget
10 Ordinance, Ordinance 17941, Section 110, Proviso P2.
- 11 2. The 2021-2022 Biennial Budget Ordinance, Ordinance 19210, Section
12 112, appropriated funding for the WaterWorks grant program.
- 13 3. Attachment A to Ordinance 18261 contains the implementation
14 guidelines for the WaterWorks grant program, including the project
15 criteria, eligibility, project selection process and administration of grants.
- 16 The implementation guidelines provide for a grant ranking committee to
17 review, rank and recommend projects for funding and for the wastewater
18 treatment division of the department of natural resources and parks to
19 administer and staff the program.

20 4. As described in Attachment A to Ordinance 18261, projects approved
21 for funding must meet eligibility criteria for water quality improvements,
22 and the grant ranking committee is to review, rank and recommend to the
23 King County executive the projects to be approved for funding, based
24 upon the eligibility criteria and ability of the applicants to demonstrate
25 water quality benefits and implementation strength.

26 5. The grant ranking committee convened twelve times in 2021 to review
27 and rank grant proposals and has recommended funding for the projects
28 listed in section 1 of this ordinance, based upon the eligibility criteria,
29 water quality benefits and implementation strength.

30 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

31 SECTION 1. The King County council authorizes the funding of WaterWorks





From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
