1 AN ORDINANCE approving the grant funding allocation
2 for projects funded through the 2020-2025 parks,
3 recreation, trails and open space levy grant program in
4 accordance with Ordinance 18890, Motion 15378,
5 Ordinance 19166 and the 2021-2022 Biennial Budget
6 Ordinance, Ordinance 19210, Section 93.

7 **STATEMENT OF FACTS:**

- 8 1. Ordinance 19166 established grant award criteria and the process for
9 the King County parks, recreation, trails and open space levy grant
10 programs, as well as the proposed composition of advisory committees in
11 accordance with Ordinance 18890, Section 6, Motion 15378, Section F.1.,
12 and Attachments A, B, D and E to Motion 15378.
- 13 2. Ordinance 18890, which took effect May 13, 2019, called for a special
14 election to authorize the King County parks, recreation trails and open
15 space levy. On August 6, 2019, King County voters approved the levy,
16 which included funding for various grant programs, including parks
17 capital and open space and aquatics facilities.
- 18 3. The parks capital and open space grant program under Attachment A to
19 Ordinance 19166 will provide funding for a range of land improvements,
20 including land acquisition, park and open space development, habitat

21 conservation, community gardens and construction of passive and active
22 recreation facilities. The goal of the program is to acquire lands that might
23 be lost to future development pressures, and also to construct new and
24 improved facilities to address rapid growth in urban areas.

25 4. The aquatic facilities grant program under Attachment C to Ordinance
26 19166 will provide levy proceeds for a wide range of improvements to
27 public aquatics facilities located in King County. The projects may
28 include feasibility studies, design, permitting and new construction or
29 improvements to existing capital facilities. The grant program will assist
30 communities as the region grows and existing facilities become obsolete
31 or reach capacity.

32 5. The aquatic facilities grant and parks capital and open space grant
33 advisory committee convened in the fall of 2021 to review and score grant
34 proposals and has recommended funding for the projects listed in sections
35 1 and 2 of this ordinance, based upon the eligibility and additional criteria
36 set forth in Attachments A and C to Ordinance 19166.

37 6. These recommendations reflect the first round of what is expected to be
38 a three-round grant cycle over the course of the levy. The second round of
39 grants is expected to begin in 2022, and the third and final round of grants
40 is expected to begin in 2024.

41 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

42 SECTION 1. The King County council authorizes the funding of parks capital

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of a DocuSign envelope instead of signing it. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.
