**SUMMARY OF RECOMMENDATIONS:**

Department's Recommendation:	Approve 1.42 acres for 40% of assessed value
Examiner's Recommendation:	Approve 1.42 acres for 10% of assessed value

Note: Because the subject properties are within Seattle city limits, Seattle will also need to approve this application for it to take effect. Seattle is currently scheduled to act on June 11.

PRELIMINARY REPORT:

On March 7, 2025, the Department of Natural Resources and Parks (DNRP) submitted its report on file no. E24CT009S to the Examiner.

PUBLIC HEARING:

After reviewing the preliminary report and examining available information on file with the application, the Examiner conducted a remote public hearing on the application on March 20, 2025.

Participants at the public hearing and the exhibits offered and entered are listed in the attached minutes. A verbatim recording of the hearing is available in the Hearing Examiner’s Office.

FINDINGS AND CONCLUSIONS:

1. General Information:

2. The Applicant timely filed an application to King County for the Public Benefit Rating System (PBRs) program current use valuation of the property to begin in 2025. As required by law, notification of the application occurred.
3. A summary of relevant PBRs categories follows below. (Plain text represents a category an applicant requested an award for and that DNRP agrees is warranted. And an \*asterisk\* represents a category where DNRP finds an award is warranted, but only if certain contingencies or conditions are met.)

The DNRP-recommended score of 13 points results in a current use valuation of 40% of assessed value for the enrolled portion of the property.

4. Additional credit may be awarded administratively under the surface water quality buffer category, urban open space category, watershed protection area category, and resource restoration category, provided that, **by October 1, 2025**, DNRP approves the resource restoration plan the Applicant has already submitted. Award of credit under these categories will increase the point total to 38 and result in a current use valuation of 10% of assessed value for the enrolled portion of the property.
5. As to the land area recommended for PBRS enrollment, the Applicant requested 1.42 acres and DNRP recommends 1.42 acres. (Enrollment acreage is the entire parcel less the excluded area, as calculated by DNRP. In the event the County Assessor's official parcel size is revised, the PBRS acreage shall be administratively adjusted to reflect that change.)
6. Except as modified herein, we find the facts set forth in DNRP's preliminary report and testimony at the March 20, 2025, public hearing correct and we incorporate them by reference. We will provide copies of this report and DNRP's report to the Metropolitan King County Council for final approval.
7. Approval of 13 points and a current use valuation of 40% of assessed value for 1.42 acres, and conditional approval of 25 additional points and 10% of assessed value for 1.42 acres, are consistent with KCC chapter 20.36 and with the purposes and intent of King County to maintain, preserve, conserve, and otherwise continue in existence adequate open space lands and to assure the use and enjoyment of natural resources and scenic beauty for the economic and social well-being of King County and its citizens.

#### RECOMMENDATION:

1. APPROVE a current use valuation of 40% of assessed value for the 1.42-acre enrolled portion of the property.
2. CONDITIONALLY APPROVE additional credit for the surface water quality buffer category, urban open space category, watershed protection area category, and resource restoration category, provided that, **by October 1, 2025**, DNRP approves the resource restoration plan the Applicant has already submitted, resulting in a current use valuation of 10% of assessed value for the 1.42-acre enrolled portion of the property.

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, King County-Department of 02 (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ### **Getting paper copies**

### **Withdrawing your consent**
