AN ORDINANCE amending King County Zoning Resolution No. 25789, as amended, by amending the Zoning Map thereof reclassifying certain property thereon at the request of Terrence Holowach, Building and Land Development Division File No. 299-78-R.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Terrence Holowach petitioned on June 22, 1978, that the property described in Section 3 below be reclassified from RM 2400, RM 900 and BN to BC and this application was assigned Building and Land Development Division File No. 299-78-R.

The report and recommendation of the Building and Land Development Division was transmitted to the Zoning and Subdivision Examiner on October 19, 1978, and hearing was held by the Examiner on the matter October 26, 1978. The report of the Examiner was filed with the Clerk of the King County Council on 20 November 27, 1978, and the Council approved the reclassification 21 by Motion No. 03876 on December 4, 1978, subject to conditions which will be satisfied per the "P" suffix.

The legal description of the property to be re-SECTION 3. classified is attached as Appendix A and is hereby made a part of this ordinance. The above described property is shown on the attached map which is designated Appendix B and is hereby made a part
