RESOLUTION NO. 752

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF EAST PIERCE FIRE & RESCUE, (FORMERLY PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 22) PROVIDING FOR THE SUBMISSION TO THE QUALIFIED ELECTORS OF THE DISTRICT AT A SPECIAL ELECTION TO BE HELD WITHIN THE DISTRICT ON AUGUST 5, 2014, IN CONJUNCTION WITH THE STATE PRIMARY ELECTION TO BE HELD ON THE SAME DATE, OF A PROPOSITION AUTHORIZING THE LEVY OF A GENERAL TAX ON THE TAXABLE PROPERTY WITHIN THE DISTRICT IN EXCESS OF CONSTITUTIONAL AND STATUTORY LIMITATIONS IN THE SUM OF \$19,200,000; **YEAR 1** - \$4,700,000, WHICH IS APPROXIMATELY \$0.53 PER \$1,000 OF ASSESSED VALUATION (BASED ON AN ASSESSMENT RATIO OF 100% OF TRUE AND FAIR MARKET VALUE), TO BE COLLECTED IN 2015; **YEAR 2** - \$4,800,000, WHICH IS APPROXIMATELY \$0.52 PER \$1,000 OF ASSESSED VALUATION (BASED ON AN ASSESSMENT RATIO OF 100% OF TRUE AND FAIR MARKET VALUE), TO BE COLLECTED IN 2016; **YEAR 3** - \$4,800,000, WHICH IS APPROXIMATELY \$0.50 PER \$1,000 OF ASSESSED VALUATION (BASED ON AN ASSESSMENT RATIO OF 100% OF TRUE AND FAIR MARKET VALUE), TO BE COLLECTED IN 2017; and **YEAR 4** - \$4,900,000, WHICH IS APPROXIMATELY \$0.48 PER \$1,000 OF ASSESSED VALUATION (BASED ON AN ASSESSMENT RATIO OF 100% OF TRUE AND FAIR MARKET VALUE), TO BE COLLECTED IN 2018, ALL TO PROVIDE FUNDS REQUIRED BY THE DISTRICT TO MAINTAIN OPERATIONAL CAPABILITIES, TO AVOID A REDUCTION IN THE NUMBER OF FIREFIGHTER EMPLOYEES, AND FOR MAINTENANCE AND OPERATION EXPENDITURES ESSENTIAL FOR BASIC FIRE AND LIFE PROTECTION NEEDS.

WHEREAS: It is the judgment of the Board of Commissioners of the district that it is essential and necessary for the protection of the health, life and property of the residents of the district that the fire and emergency medical services enumerated in this resolution be provided by the district. Such services will necessitate the expenditure of revenues for maintenance, operations and equipment in excess of those which can be provided by the district's regular tax levy for collection beginning in 2015 and ending in 2018, such excess being not less than \$19,200,000; Now, Therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF EAST PIERCE FIRE AND RESCUE (FORMERLY PIERCE COUNTY FIRE PROTECTION DISTRICT NO. 22), PIERCE COUNTY, WASHINGTON, AS FOLLOWS:

SECTION 1. The district does not obtain sufficient revenue from its regular property tax levy to provide fire and emergency medical services at the level that it currently provides. The purpose of this special levy would be to provide sufficient funds to maintain the level of services during 2015 through 2018. The funds obtained through this levy will be used to pay regular maintenance and operation costs and to maintain the current level of emergency services. This maintenance and operations levy would not only allow East Pierce Fire and Rescue to make up for funding lost during the recent recession, which has caused property values to decline for approximately five years, but also would allow the district to hire additional firefighters for the first time in many years, to maintain services in light of increasing population to be served.

SECTION 2. In order to produce revenue sufficient to pay the costs of providing adequate fire protection and emergency medical services as described in Section 1 of this resolution and to maintain reserve funds sufficient to assure the continuation of such services, the district shall levy in 2014, and collect in 2015, a general tax on taxable property within the district, in excess of the regular levy, for maintenance and operation costs in the amount of \$4,700,000; the district shall levy in 2015, and collect in 2016, a general tax on taxable property within the district, in excess of the regular levy, for maintenance and operation costs in the amount of \$4,800,000; the district shall levy in 2016, and collect in 2017, a general tax on taxable property within the district, in excess of the regular levy, for maintenance and operation costs in the amount of \$4,800,000; the district shall levy in 2017, and collect in 2018, a general tax on taxable property within the district, in excess of the regular levy, for maintenance and operation costs in the amount of \$4,900,000.

SECTION 3. There shall be submitted to the qualified electors of the district for their ratification or rejection, at an election on August 5, 2014, in conjunction with the state primary election to be held on the same date, the question of whether or not such levy for maintenance and operations, in excess of the constitutional and statutory limits, shall be made. The Board of Commissioners hereby requests that the Auditors of Pierce County and King County, as ex-officio Supervisors of Elections, call such special election, to submit the following proposition at such election, in the form of a ballot title substantially as follows:

PROPOSITION 1

East Pierce Fire & Rescue
(Formerly Pierce County Fire Protection District No. 22)
Property Tax Levy
For Maintenance and Operation Expenses

The Board of Fire Commissioners of East Pierce Fire & Rescue (formerly Pierce County Fire Protection District No. 22) adopted Resolution No. 752 concerning a proposition to finance maintenance and operation expenses. This proposition, if approved, will authorize the District to levy, without regard to the dollar rate and percentage limitations imposed by chapter 84.52 RCW, a property tax upon all taxable property within the District of:
