RESOLUTION NO. 11-1_2013

A RESOLUTION of the Board of Directors of Skykomish School District #404, King County, Washington providing for the submission to the qualified Electors of the District at the special election to be held on February 11, 2014 of the proposition of whether a tax of \$289,178 should be levied in 2014 for collection in 2015, whether a tax of \$302,191 should be levied in 2015 for collection in 2016, whether a tax of \$315,790 should be levied in 2016 for collection in 2017 and whether a tax of \$330,000 should be levied in 2017 for collection in 2018; said taxes being for District's General Fund, to pay part of the general expenses of the educational programs and District Operations. Be it further resolved that if the February 11, 2014 levy is not approved by the qualified Electors of the District, the Board of Directors of Skykomish School District #404, King County, Washington provided for the re-submission of said levy values to the qualified Electors of the District at a special election to be held on August 5, 2014.

WHEREAS, the money in and to be paid into the General Fund of Skykomish School District #404, King County, Washington, by State and Federal Authority, during the 2014-15, 2015-16, 2016-17 and 2017-2018 school years will be insufficient to enable the District to pay for necessary educational programs and District Operations and to meet the goals of Skykomish School District including Student Assessment, Facilities Planning, Communication to the Community, Operations and Fiscal Planning; and

WHEREAS, in order to properly provide for such educational goals, the Board of Directors of the District deems it necessary to levy the following taxes for the District General Fund upon all the taxable property within the District in excess of the maximum annual tax levy permitted by law to be levied within the District without a vote of the electors:

- A. A tax of approximately \$1.75 per thousand dollars of assessed valuation to provide \$289,178 said levy to be made in 2014 for collection in 2015 and
- B. A tax of approximately \$1.79 per thousand dollars of assessed valuation to provide \$302,191 said levy to be made in 2015 for collection in 2016; and
- C. A tax of approximately \$1.83 per thousand dollars of assessed valuation to provide \$315,790 said levy to be made in 2016 for collection in 2017; and
- D. A tax of approximately \$1.88 per thousand of assessed valuation to provide \$330,000 said levy to be made in 2017 for collection in 2018.

WHEREAS, the Constitution and laws of the State of Washington require that the question of whether or not such tax may be levied must be submitted to the qualified electors of the District for their ratification or rejection;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Skykomish School District #404, King County, Washington as follows;

Section 1: The following taxes for the District's General Fund should be levied upon all the taxable property within the district in excess of the maximum annual tax levy permitted by law to be levied within the district without a vote of electors;

- A. A tax of approximately \$1.75 per thousand dollars of assessed valuation to provide \$289,178 said levy to be made in 2014 for collection in 2015 and
- B. A tax of approximately \$1.79 per thousand dollars of assessed valuation to provide \$302,191 said levy to be made in 2015 for collection in 2016; and
- C. A tax of approximately \$1.83 per thousand dollars of assessed valuation to provide \$315,790 said levy to be made in 2016 for collection in 2017; and
- D. A tax of approximately \$1.88 per thousand of assessed valuation to provide \$330,000 said levy to be made in 2017 for collection in 2018.

Upon approval by the voters of the proposition set forth below, the district may use the proceeds of said levies during the school years of 2014-15, 2015-16, 2016-17 and 2017-18 by incurring an indebtedness by the insurance of short term obligations against the General Fund of the District, as authorized by Chapter 39.50 RCW, and may expend the proceeds of said levies to pay such part of the general expenses of educational programs and District operation during such school years as may be authorized or allowed by law for the use of such levy funds.

Section 2: The King County Department of Records and Elections, as ex-official supervisor of elections in King County is hereby requested to conduct said election to be held on said date and to submit to the qualified electors of the District the proposition hereinafter set forth.

The Secretary of the Board of Directors is hereby authorized and directed to certify said proposition in the following form
